MEMORANDUM OF UNDERSTANDING / AGREEMENT

This Memorandum of Undertaking is made on 10<sup>th</sup> June, 2019 between GRAND ACADEMIC PORTAL (GAP) herein refer to as GAP having its office at Loha Bhavan, Ashram Road, Ahmedabad, Gujarat-380009 which expression shall include authorized representative of first part NALANDA NRITYA KALA MAHAVIDYALAYA , having its Office at PLOT A-7/1, N.S. ROAD NO. 10, J.V.P.D. SCHEME, VILE PARLE WEST, MUMBAI - 400049.

The Programme for which this Memorandum of Understanding is signed is to be known as "Promotion of Academic activities of both the institutions.

Whereas the NALANDA NRITYA KALA MAHAVIDYALAYA, is desirous of undertaking a joint project for the training and handholding component of the said Scheme with GAP, the two parties to this Memorandum of Understanding, with the intention of both being academically bound, accept the following terms and conditions:

**1. Coordination and Contact Points**

a. GAP for coordination on broad policy issues and matters related to centralized operations.

b. NALANDA NRITYA KALA MAHAVIDYALAYA, for all operational matters, which includes Workshop, Conference, Counseling, Seminar, training, handholding component as per GAP guidelines.

**2. Responsibilities of the NALANDA NRITYA KALA MAHAVIDYALAYA, PLOT A-7/1, N.S. ROAD NO. 10, J.V.P.D. SCHEME, VILE PARLE WEST, MUMBAI - 400049.**

The NALANDA NRITYA KALA MAHAVIDYALAYA shall;

a) Organize training and handholding activities under the Scheme as per the GAP guidelines.

b) Ascertain for itself the financial viability of the project and shall fund all cost over runs, if any;

c) Not make any financial commitment on behalf of GAP, nor shall take loans or create any other financial liability binding GAP under this agreement;

d) Have all employees relating to this project invite outside Guest Speakers/faculty on its own, and GAP shall have no legal, financial or any other responsibility towards them;

e) Follow the course outline supplied by GAP, as may be amended from time to time;

- f) Conduct no such parallel activity which may be prejudicial to the interests of the said Scheme, or GAP;
- g) Maintain records of the students and their regular attendance, and share them with GAP;
- h) Provide assistance for conduct of study visits, field visits, etc.;
- i) Not realize any fee from the students in any form whatsoever;
- j) Incur expenditure on all operations/services as per the financial guidelines of GAP.
- k) Provide free of cost handholding facilities, counseling and guidance to the students for 1 year after the training.
- l) Register candidates for organizing training programmes

**3) Responsibilities of GAP:**

The GAP shall:

- a. Develop and provide broad course outline to the NALANDA NRITYA KALA MAHAVIDYALAYA
- b. Provide list of students allotted to each NALANDA NRITYA KALA MAHAVIDYALAYA, or be entitled to ask training institute to generate applications.
- c. Provide norms and guidelines wherever necessary;
- d. Provide timely clarifications regarding Academic Inputs and any other necessary information to the NALANDA NRITYA KALA MAHAVIDYALAYA,
- e. Shall ensure through proper co-ordination and consultation that all the NALANDA NRITYA KALA MAHAVIDYALAYA, provide quality training under the said Scheme
- f. Organize Conference, Seminar and Workshop.
- g. Two faculties of the college will be appointed as an editor for the period of ten years
- h. GAP will do GAAC accreditation without charging any administration fees, but the college for the accreditation of GAAC will pay TA and DA of the peer members along with honorarium of Rs 5000/-
- i. College will remain as an academic partner in all conferences workshop and seminar organized by the GAP for the period of 10 years.
- j. Logo of the college will be uploaded as an institutional member on the website and college have to upload the same.
